San Fernando Valley Academy encourages its parents to spend more time with their child at home, but, if parents need afterschool care, San Fernando Valley Academy offers PAID supervision for Elementary students, <u>starting fifteen (15) minutes</u> <u>after each class is over.</u>

After school closing hours: Monday through Thursday at 6 p.m. and Friday/Minimum Days at 4:30 p.m.

Monday through Thursday: GRADE After-school charge at:

Kindergarten2:45 p.m.1 and 23:00 p.m.3 and 43:00 p.m.5 and 63:30 p.m.7 and 83:30 p.m.

Friday and Minimum days*: GRADE After-school charge at:

Kindergarten to 8 12:30 p.m.

The HOURLY rate is: \$ 2.00 per hour, per child.

Charges start 15 minutes after the dismissal of the last child from the Elementary section

Electronics are not allowed, unless is for homework and IXL practices, with the after-school care Director approval

SPORTS PARTICIPATION

If a child is participating in any sport, the child must be picked up by the coach from the after-school area.

When the sport activity is over, the child will be sent to the after-school care, where after-school charges will apply.
